General Notes

- FRAMING LUMBER TO BE GRADE NO 1&2 SPOUCE UNLESS OTHERWISE SPECIFIED.
- FLOOR JOISTS SHALL BE DOUBLED UNDER PANEL PARTITIONS AND SHALL BE LACED 4" APART TO ACCOMMODATE PLUMBING.
- AS A PRECAUTION, A FIREPROOF LINER SHOULD BE INSTALLED BETWEEN FIREBOX COMBUSTIBLE FRAMING.
- MINIMUM FOUNDATION DEPTH BELOW FINISHED GROUND LEVEL IS 4'-6". DEPTH MAY VARY DEPENDING ON LOCATION.
- EXTREMITIES OF STEEL BEAMS SUPPORTED ON EXTERIOR WALL SHALL BE INSULATED A MINIMUM DISTANCE OF 24".
- WINDOW DIMENSIONS MAY VARY BETWEEN MANUFACTURERS - VERIFY ROUGH OPENING SIZES.
- BASEMENT WINDOWS BELOW GRADE SHALL BE PROTECTED BY GALV STEEL WINDOW WELLS AND A GRAVEL FILLED 4" DRAIN CONNECTED TO A PERIMETER DRAIN AND INSTALLED ACCORDING TO THIS PLAN.
- CERTAIN DIMENSIONS MAY VARY DEPENDING ON MATERIALS USED AND/OR THE CONTRACTORS BUILDING METHODS IF VARIATIONS EXIST BETWEEN THE BUILDING SITE AND PLANS, THE CONTRACTOR MUST ADVISE DRW DESIGN ASAP.
- WRITTEN DIMENSIONS ALWAYS TAKE PRECEDENCE OVER SCALE MEASURES.
- BUILDING CONTRACTOR MUST:
  - 1) VERIFY ALL DIMENSIONS BEFORE PROCEEDING.
  - 2) RESPECT IF APPLICABLE, REQUIREMENTS OF DOCUMENTATION ATTACHED TO PLANS AND INFORM CLIENT OF ANY CONSEQUENCES RESULTING FROM CHANGES TO PLAN.
